

Consumer Health Data Privacy Policy

Belred Family Medicine PLLC dba Advanced Family Medicine PLLC

Effective Date: January 16, 2025 (Revised February 2026)

This policy is provided to comply with the Washington My Health My Data Act. It describes how **Belred Family Medicine PLLC dba Advanced Family Medicine PLLC** (“we,” “us,” or “our”) collects, uses, and shares “Consumer Health Data” from individuals in Washington state.

1. Categories of Consumer Health Data We Collect

We may collect the following categories of health data:

- **Health Conditions & Treatments:** Information regarding your medical history, symptoms, diagnoses, or testing (e.g., when you use our online appointment request form).
- **Precise Location Information:** If you use our website to “find a clinic near me,” we may process location data that could indicate your attempt to receive healthcare.
- **Inferred Health Status:** Information we derive from your interactions with our website (e.g., if you spend time reading our pages on “diabetes management,” we may infer an interest in that health condition).

2. Purpose of Collection and Use

We collect and use your Consumer Health Data for the following purposes:

- **To provide requested services:** Specifically to schedule appointments and respond to your inquiries.
- **Essential Business Operations:** Including troubleshooting our website and maintaining security.
- **Legal Compliance:** To meet our obligations under Washington law.
- **Note:** We do not collect your data for marketing or targeted advertising purposes without your explicit opt-in consent.

3. Categories of Sources

We collect health data directly from you when you:

- Fill out contact or appointment forms on our website.
- Search for specific health conditions or services on our site.
- Interact with our patient portal.

4. Sharing of Consumer Health Data

We only share your Consumer Health Data with the following categories of third parties:

- **Service Processors:** Vendors who help us run our website or patient portal (e.g., your EHR provider or website host). These vendors are contractually prohibited from using your data for any other purpose.
- **Authorized Affiliates:** [List specific parent companies or partner clinics, or state "None"].
- **Law Enforcement:** Only when required by a valid legal process.
- **We do NOT "sell" your health data.**

5. Your Rights Under Washington Law

You have the following rights regarding your Consumer Health Data:

- **Right to Access:** You may confirm if we are collecting your data and request a list of all third parties with whom we have shared it.
- **Right to Withdraw Consent:** You may withdraw your consent for our collection or sharing of your data at any time.
- **Right to Deletion:** You may request that we delete your consumer health data.
